New Code	ADA/CDT Short Description	ADA/CDT Full Description
D0396	3D PRINT DENTAL SURFACE SCAN	3D printing of a 3D dental surface scan to obtain a physical model.
D1301	IMMUNIZATION COUNSELING	A review of a patient's vaccine and medical history, and discussion of the vaccine benefits, risks, and consequences of not obtaining the vaccine. Counseling also includes a discussion of questions and concerns the patient, family, or caregiver may have and suggestions on where the patient can obtain the vaccine.
D2976	BAND STABILIZATION PER TOOTH	A band, typically cemented around a molar tooth after a multi-surface restoration is placed, to add support and resistance to fracture until a patient is ready for the full cuspal coverage restoration.
D2989	EXCAVATION OF TOOTH	excavation of a tooth resulting in the determination of non-restorability
D2991	HYDROXYAPATITE MEDICAMENT TOOTH	application of hydroxyapatite regeneration medicament – per tooth Preparation of tooth surfaces and topical application of a scaffold to guide hydroxyapatite regeneration.
D6089	RETORQUING IMPLANT SCREW TOOTH	accessing and retorquing loose implant screw – per screw
D7284	EXCISIONAL BIOPSY SALIVARY GLAND	excisional biopsy of minor salivary glands
D7939	OSTEOTOMY VIRTUAL GUIDANCE	indexing for osteotomy using dynamic robotic assisted or dynamic navigation A guide is stabilized to the teeth and/or the bone to allow for virtual guidance of osteotomy.
D9938	CLEAR TEMP AESTHETIC APPL FAB	fabrication of a custom removable clear plastic temporary aesthetic appliance
D9939	CLEAR TEMP AESTHETIC APPL PLACE	placement of a custom removable clear plastic temporary aesthetic appliance
D9954	ORAL APPLIANCE THERAPY DEVICE	fabrication and delivery of oral appliance therapy (OAT) morning repositioning device Device for use immediately after removing a mandibular advancement device to aid in relieving muscle/jaw pain and occlusal changes.
D9955	ORAL APPLIANCE THERAPY	oral appliance therapy (OAT) titration visit Post-delivery visit for titration of a mandibular advancement device and to subsequently evaluate the patient's response to treatment, integrity of the device, and management of side effects.
D9956	HOME SLEEP APNEA TEST	Administration of home sleep apnea test. Sleep apnea test, for patients who are at risk for sleep related breathing disorders and appropriate candidates, as allowed by applicable laws. Also, to help the dentist in defining the optimal position of the mandible.
D9957	SCREEN SLEEP BREATHING DISORDER	screening for sleep related breathing disorders Screening activities, performed alone or in conjunction with another evaluation, to identify signs and symptoms of sleep-related breathing disorders.

D5876	METL SUBC TO ACR DENT PER ARCH	Add metal substructure to acrylic full denture (per arch). Use of metal substructure in removable complete dentures without a framework.
D2335	4 OR MORE SURF COMPOSITE ANT	resin-based composite – four or more surfaces (anterior)
